

## **COVID ARENA PROTOCOLS**

### **Newcastle**

- Show up max 30 minutes prior to ice time.
- No spectator limit.
- Dressing rooms are open.
- Masks required inside (not players on ice).

**Spectators** - will need to show vaccination status and ID at the door.

**Players/Coach staff** - Team managers must show a roster sheet with vaccination status for all as well as COVID screening checks.

### **Brock**

- Everyone needs to show ID and proof of vaccination at the door. Security will check for both.
- Face masks are mandatory in the building.
- 70 people are allowed in the building including players and team officials.
- Players are able to remove masks before going on the ice but must wear them while getting ready and undressed.
- Coaches must wear masks at all times.
- Players/Spectators must arrive no more than 20 minutes prior to ice time and must vacate 20 minutes after.
- No warm-ups are allowed in the building.
- Players must bring their own water bottles.
- Spectators must go directly to the stands, there is no congregating in the lobby
- Teams may bring a pre-filled checklist but the COVID rep or coach must check everyone off and that copy gets added to the book

### **Millbrook**

- There will be a security guard at the door of the CMCC Mon-Fri from 4-11p and Sat/Sun all day to passively screen everyone entering the building, record contact tracing info for all spectators and verify vaccine status of every individual entering the building who is

12 years or older (currently excluding players). After Nov 26th, players will also be required to show proof of vaccination to the security upon entry if they are 12 or older.

- Everyone entering the building is required to complete the MDMHA Online Covid Screening

- Coaches will need to submit sign in forms for all of their on ice participants when entering the building (sheets should include, name, phone and COVID health screening) Sheets are available at the rink if needed
- Teams can enter the building 30 minutes prior to your ice time and must exit the building within 20 minutes after the ice time.
- All players must wear masks until going on the ice. Coaches and Trainers must wear masks at all times.

**Bewdley Policies**

- All players or spectators that are entering the Bewdley arena must first complete the following Covid Screening form:

- Each visiting team will need to complete and submit a sign sheet for all players, bench staff and spectators.
- All Patrons will enter through the main entrance and doorways and hallways will be clearly marked to prevent congestion.
- Entrance to the building is permitted 30 minutes prior to the ice booking start time.
- Face coverings must be worn until players put on their helmets, and coaches and trainers must keep face coverings on at all times.
- Coaches, trainers, sports volunteers must wear PPE (medical grade mask and eye protection) if they cannot maintain 2 metres distance from anyone who is not wearing a mask, and they are not separated by an impermeable barrier.

- Players will be permitted to bring their hockey equipment bag and 1 clearly labeled water bottle into the arena/dressing room.
- As per OMHA regulations all players and spectators born 2009 and earlier must show that they have their second vaccination at least 14 days prior to the game date
- At the end of the allocated ice time teams will have 30 minutes to change and exit the facility.
- Exiting the building will take place at the designated exit doors located at the West side of the Cavan Monaghan Community Centre.

## Durham

### Oshawa Arenas:

Effective Friday, October 22 City of Oshawa arenas will be at full capacity for spectators.

There will no longer be time restrictions as to when teams/spectators can enter the facility, however dressing rooms may not always be available earlier than 30 minutes prior to their game/practice. Spectators should leave immediately after the rental and teams must vacate within 20 minutes as congestion/congregation still needs to be kept to a minimum. Any warm-ups should be done outside.

Requirements related to proof of vaccination and completion of the City of Oshawa online screening are still in effect.

### Whitby Arenas:

#### Facility Information:

- Water bottle filling stations will be available
- Change rooms will be available
- Showers will be available
- Team Warm ups **are not permitted** in the facility
- Concessions are **not available** at this time

#### Facility Access for Iroquois Park Sports Complex, McKinney Centre, Luther Vipond Memorial Arena:

- Access will be provided to team dressing rooms up to **30 minutes** prior to the permitted time. This time will allow staff to complete cleaning and disinfecting of the dressing rooms between permits.

- Access will be permitted through all facility doors however it is **highly recommended** that participants access through the arena entrance associated with **their permit to limit the wait times** as a result of the need to provide COVID-19 Screening and Proof of Vaccination.
- Spectators will be granted access to arenas for viewing of games and practices

**Provincial Safety Regulations Still in place:**

- **Proof of vaccination** is required for all patrons attending Recreation Centres, Community Centres, Arenas, and indoor programming at Town Facilities

**Exemptions include:**

- Individuals under 18 years old who are entering the facility to participate in organized sport (sports leagues, organized pick-up sports, dance classes, martial arts, swimming classes). Proof of identification and proof of being fully vaccinated is not required for volunteers, coaches and officials.
- Children under 12 years old.
- Individuals attending a wedding, funeral or religious rite or ceremony (note this excludes the social component associated with these services).
- Individuals with a medical exemption. A note from a Medical Doctor (MD) or Registered Nurse Extended Class (RNEC) or Nurse Practitioner (NP) will be required should a medical exemption be requested. The note must include that there is a medical reason for the individual's exemption from being fully vaccinated against COVID-19, and the effective time-period for the medical reason.
- Masks are required to be worn when in the facility and not actively participating in sport activity.
- Please physical distance when possible.

**Mariposa/Woodville/Sturgeon/Lindsay.Kawartha/Manvers- Kawartha Lakes Procedures**

As the COVID-19 (coronavirus) outbreak continues to evolve, health and safety is our number one priority. To ensure the health and safety of the community cooperation is required from everyone.

**Safety measures in place include, but are not limited to, the following:**

- Screening before entering the facility

- Physical distancing
- Hand sanitizing upon entry and exit of the facility
- Restrictions on the number of users and spectators
- One-way entrance into the facility, individual ice pad and designated exits using
- directional floor markers to support physical distancing
- Enhanced cleaning of the facility following each ice rental
- No access to the general public
- Designated COVID-19 Representative provided by each ice user group
- Proof of vaccination required to access facilities.

### Orono

- Upon arrival, **EVERYONE** entering the arena must scan the QR code at the entrance to the arena and fill out the online form. This is for contact tracing purposes. **PLEASE REMEMBER TO DO THIS.** This can be done prior to attending too - the form is on [oaaa.ca](http://oaaa.ca) under the Orono Arena tab. This is a requirement by the Health Department
- Please do not enter the arena until 30 minutes before your scheduled ice time
- Spectators aged 12 and older must show proof of vaccination and corresponding identification.
- Masks must be worn inside the facility at all times by all persons entering.
- Dressing rooms, public washrooms and the Canteen are **open** for your use.
- Players are to go to their dressing room and remain inside the dressing room until they are told to go on the ice.
- Parents are strongly discouraged from going to the dressing room area to prevent crowding. If there is an issue such as tying skates, please make arrangements with a coach or on-ice helper to tie the skates or come with them already on as we did last season
- Spectators are encouraged to watch the game/practice from the cold viewing area. Spectators may watch from the warm lobby area but social distancing is still required.
- Once the teams from the practice before come off the ice, the players will be allowed to go and sit on the bench until the Olympia is finished cleaning the ice. This is when players and coaches can remove their masks. There is **no** loitering in the dressing room hallway again to prevent crowding.

- Players are expected to vacate the dressing rooms within 15 minutes of coming off the ice.

## **Norwood**

### **Asphodel Norwood Community Center Protocols/Rules**

- Entry to the arena will be 15 minutes before for players and up to 4 team staff.
- Entry for spectators will be 5 minute prior - doors will lock at this time so please be on time.
- All on ice participants must enter fully dressed and wearing a mask with the exception of skates, helmets, gloves and sticks can be brought in. Dressing rooms are for putting on skates , helmets and gloves only at this time. It is encouraged that players wear their skates and use skate guards.
- **Please bring your own WELL MARKED water bottle**
- **2 adult/guardian/Spectators per player (NO EXCEPTIONS)**
- Use hand sanitizer provided upon entry
- Masks are to be worn and please respect social distancing of 2m
- **Please complete ONLINE SCREENING 2-6 hours before entry** - can be found on our website - for now when you complete a copy will be sent to your email which you will show upon entry that it is complete.
- If you have any COVID symptoms entry will be denied
- Spectators will only be in the Cold part - so please dress accordingly, no in and out privileges
- Please adhere to all directional signage while in the facility
- Absolutely NO outside food or drinks.

## **Vaccinations**

OMHA distributed an announcement today confirming The **OMHA Vaccination POLICY will stay in effect meaning all players 12+ must be fully vaccinated on or before October 31, 2021 to participate in OMHA sanctioned activities.**

Asphodel Norwood Community Centre also released documentation today supporting the Provincial order that **As of Sept 22, ALL COACHES,STAFF, REFEREES, SPECTATORS 12+ must show that they have been fully vaccinated to enter the Norwood arena**

**Vaccine verification** starts Sept 22 for all coaches, staff, referees, spectators 12+. Proof of vaccination along with ID will be required - A **NDMS** representative will be checking upon entry. Please have it ready in hand. Please go to the **WHITE BOOTH** in front of the rink to check in each time.

### **Highstorm** **North Durham**

Effective Wednesday, September 22, proof of vaccination will be required to enter Township recreation facilities as per the Ontario's Proof of Vaccination Policy.

### **Scugog:**

As required by the Province, all patrons 12 years and older must be fully vaccinated (both doses of a two doses vaccine or one dose of a single dose vaccine plus 14 days) and provide proof of vaccination along with identification on each visit. Proof of vaccination does not apply to youth 12 to 17 years old who are actively participating in organized sport (training, practices, games and competitions). Individuals can provide proof of vaccination by downloading or printing their vaccine receipt from the province booking portal or by calling the Province Vaccine Booking Line at 1-833-943-3900.

When patrons arrive at the Scugog Community Recreation Centre, a security guard will be at the entrances to ask for proof of vaccination for applicable patrons and spectators. To protect the privacy of our patrons, information will not be stored. Visitors and spectators 12 years and older will be asked to provide the documentation each time they enter the facility, unless they are a youth 12 to 17 that will be actively participating in an organized sport. Individuals with a medical exemption are required to present identification and a written document, signed by a physician or registered nurse in the extended class information, stating the individual is exempt for a medical reason.

All other public health measures (e.g., masking and physical distancing) continue to apply.

- Recreation facilities and meeting rooms include:
- Scugog Community and Recreation Centre (SCRC)
- Blackstock Recreation Complex
- The Lookout Youth Centre
- Meeting Rooms and Community Halls for Wedding and Religious Ceremonies

- For wedding and funeral services, rites or ceremonies proof of vaccination is not required
- For wedding and funeral social gatherings (receptions) anyone over the age of 12 will be required to provide proof of vaccination
- Proof of vaccination will be required October 13. From Sept 22-Oct 12 a negative result of a COVID-19 antigen test may be provided instead of proof of being fully vaccinated

The Township of Scugog continues to follow provincial and regional guidelines as it relates to the COVID-19 pandemic and vaccination requirements for the protection of the community. All requirements, exemptions and policies are subject to change based on provincial regulation. The Township of Scugog and our users renting the facilities are working together for the safety of the community and will follow all provincial guidelines.

### **Uxbridge:**

The Province of Ontario has announced that fitness and recreational facilities must require each patron who enters an area of the premises to provide proof of being fully vaccinated against COVID-19. An individual is considered fully vaccinated if they have received a full series of a COVID-19 vaccine authorized by Health Canada and they have received their final dose of the series at least 14 days prior to seeking access to the facility. This mandate is effective for the Uxbridge Arena beginning September 22nd, 2021.

### **How it will work:**

#### **1. Entering the Arena (recreation facility):**

From September 22 to October 21, all adults (18+ yrs), guardians, and spectators ages 12 and older will need to present proof of vaccination prior to entry with:

- Copy of vaccine receipt reading 14 days post final dose of vaccination
- Piece of government issued ID matching the name and birth date of vaccine
- receipt (i.e. drivers license, health card)
- October 22 and beyond (date subject to change):
- Scanning unique QR code via provincial 'Proof of Vaccination' application

### **Children and Youth under 18yrs:**

Children and youth under the age of 18 who are actively participating in organized sport (including tryouts, training, development, practices, and games) are not required to



provide proof of vaccination against COVID-19 to enter the facility. Compliance of all other COVID-19 safety protocols, as listed in the Return to Ice Guidelines, remains a requirement (i.e. face coverings, physical distancing, screening, etc.).

**Note:** The age exemption for children and youth under the age of 18 does not apply to spectators. All spectators (those not engaged in sport) 12 years of age and older must provide proof of vaccination.

## **2. Entering the Community Centre (meeting or event space):**

Every patron aged 12 and older who enters the Community Centre for the purpose of a meeting, event, or organized activity must provide proof of vaccination, by way of steps above, prior to entry. By law, we are not able to keep a record that you have shown us your vaccine receipt. Please have it available each time you visit the arena.

### **What if I Have an Exemption?**

**For adults, guardians and spectators:** Only a medical exemption authorized by a Doctor or Registered Nurse Practitioner will be accepted. Please visit the link below for requirements of the medical exemption letter. Government ID along with the medical exemption letter will be required for access to the facility. After October 22, 2021, your exemption will be integrated in your QR code issued by the province.

**Thank you for your understanding and patience during this time. The Province of Ontario has mandated that we follow their directives.**

### **Visiting Team COVID Screening Protocols**

### **Visiting Team Protocols - effective October 27, 2021**

Welcome back to Ennismore!!! We are excited to be hosting you and your team. Just a few housekeeping items for your players and spectators as we navigate hockey during Covid.

- All participants 12+, including bench staff and players are to be double vaccinated plus 14 days.
- All spectators 12 and over are to be double vaccinated plus 14 days.

- There are no spectator limits at Ennismore Arena.
- Players and spectators are allowed to enter the arena 30 minutes prior to game time.
- Dressing rooms will be open to players. Showers are available.
- After the game, we ask all teams to exit the building as quickly as possible. Spectators should leave immediately.
- The exit doors are separate from the entrance.

Visiting teams are required to have their **own COVID Screener** at the entrance to Ennismore Arena 30 minutes prior to the game. There will be a table set up for the Ennismore Covid Screener & Visiting Team Covid Screener.

On game day, the visiting team participants and spectators **MUST** complete the online Ennismore Arena Contact Tracing Form before entering the arena.

All visiting participants and spectators must check-in with their own Covid Screener at the entrance to the arena within 30 minutes of the game. The following items must be verified by the screener: the contact tracing verification email, Proof of Vaccination and ID.

There is no re-entry to the arena once the game has started.

The Visiting Team COVID Screener will sign the Selwyn Attestation Form once everyone has entered the arena.
